#### LEGISLATIVE UPDATE

Thank you for your support of <u>SB514 SD1 HD1</u> <u>CD1</u>. Governor Ige signed this bill into law on July 3, 2017. Pharmacists are now authorized to administer human papillomavirus (HPV), tetanus, diphtheria, pertussis (Tdap), meningococcal, and

influenza vaccines to children 11 through 17 years of age, improving access to vaccinations statewide.
